



Prospective Marriage (300) Application Checklist - Cairo

The service standard processing time for a Prospective Marriage (Fiance) application is 12 months. This is an aspirational standard and is measured from the date we receive a **complete application**.

The Embassy works on an appointment basis for all services related to the Department of Home Affairs, including visa and citizenship applications.

To ensure you have lodged a complete application, you must:

- **answer all the questions** on the application form; include your residential address and provide contact details (including email). Do not leave any answers blank, write 'N/A' if the question does not apply to you;
- **include all supporting documents** and information as requested on this checklist. Please note that DOHA may ask for other documents during the processing of the application;
- **sign** the application and sponsorship forms; and
- **pay** the visa application charge. <http://www.border.gov.au/Trav/Visa/Visa-1>

Use this checklist to ensure that you have included all necessary documentation to support your claims and **include the completed checklist when you lodge your visa application.**

- If you are lodging an application or documents in person, you need to bring **the original documents and a clear photocopy** of those documents. We will not accept originals nor will we photocopy documents on your behalf.
- Handwritten forms must be **completed legibly and in English.**
- If you apply for the visa on-line please **attach the below documentation electronically** through immi-account

(if applicable) Form 1229 for children under 18 years old travelling without both parents. Supporting ID documents and contact details for non-travelling parents

Copy of any used pages of current and previous passports for all applicants	
2 recent Passport sized photographs of all applicants with the name written on the back	
(if applicable) The national identity card of all applicants.	
Police certificates for all applicants aged 17 years and older from each country in which they have spent a total of 12 months or more in the last 10 years or since turning 16 years of age	

(if applicable) Military service discharge certificate	
(if applicable) Evidence of any change of name and evidence of any previous names	
Applicants who have spent 28 days or longer in Afghanistan, Cameroon, Equatorial Guinea, Ethiopia, Iraq, Israel, Nigeria, Pakistan, Somalia and/or Syria after 4 May 2014 must provide polio vaccination certificates .	
<p>Birth certificates for all applicants showing both parents' names. If unable to obtain a birth certificate, provide the relevant pages of at least one of the following documents:</p> <ul style="list-style-type: none"> • family book/family registration certificate showing both parents' names • identification document issued by the government • court-issued documents that verify your identity. 	
Sponsor	Tick if included
Evidence that the sponsor is an Australian citizen, permanent resident or eligible New Zealand citizen .	
2 recent Passport sized photographs of the sponsor with their name written on the back of each photograph.	
<p>If a child under 18 years of age is included in the application OR if the sponsor is an eligible New Zealand citizen:</p> <p>Penal clearances from each country (including Australia) in which the sponsor has spent a total of 12 months or more in the last 10 years (since turning 16 years old)</p>	
Relationship Documents	Tick if included
Evidence that you and your fiancé(e) have met face to face since you both turned 18 years of age and that you are personally known to each other.	
A signed and dated letter (on letterhead) from an authorised marriage celebrant who will conduct your wedding ceremony. The letter must include a date (or date range) on which the planned marriage ceremony will take place. If you plan to marry in Australia, the celebrant must confirm that a Notice of Intended Marriage (NOIM) for you and your fiancé(e) has been lodged with them.	
Evidence that both you and the sponsor are aged 18 years or over at the time the application is lodged.	
Statements from the applicant and sponsor outlining the history and development of the relationship. Template available from Cairo Post.	
<p>Supporting documentation showing the genuine nature of the relationship and that you genuinely intend to live in a spouse relationship.</p> <p>See http://www.border.gov.au/Trav/Visa-1/300-/Prospective-Marriage-visa-(subclass-300)-document-checklist</p>	
At least 2 statements from friends or relatives outlining their knowledge of the relationship (Form 888)
